No. ERTS (E) 3/2022/121 - In exercise of the powers conferred by sub-section (1) of section 112 of the Meghalaya Value Added Tax Act, 2003 (Act No. 2 of 2005 as amended) and in supersession of the Government Notification No. ERTS(T)24/2016/69, dated 26.2.2021, except as respects things done or omitted to be done before such supersession, the Governor of Meghalaya is pleased to make the following amendment in Sl. No. 1 of Schedule V to the Act as under:-

Sl. No.	Description of Goods	Rate of Tax
1.	Liquor including foreign liquor, whether made in India or not, including brand Whisky, Vodka, Gin, Rum, liquor, Cordials, Bitters and wines or a mixture containing any of these, as also beer, ale, porter, cider, perry, and other similar potable fermented liquors except rum sold to the defense personnel in Defense Service Canteens strictly for personal consumption.	30%
